Eligibility Criteria

- Open to *Law Students* enrolled in:
 - *3rd year onwards* in a 5-Year Integrated Law Programme, OR
 - *2nd year onwards* in a 3-Year LL.B. Programme.
- Postgraduate students (LL.M. or allied disciplines) are also eligible.
- Strong academic record and demonstrated interest in *Intellectual Property Rights, Technology Law* and *Research Methodology*.
- *Preference will be provided* to students having prior editorial experience with journals, law reviews, or institutional publications.

Roles & Responsibilities

- Reviewing and editing research papers, articles, and academic submissions for CDIPR publications.
- Ensuring adherence to citation and formatting standards (OSCOLA, Bluebook, APA, or as prescribed).
- Assisting the Editorial Advisory Board in maintaining academic integrity and publication quality.

3. One Writing Sample (Published/Unpublished; preferably academic/research-based).
