DRISTI Portal is conceived as a comprehensive knowledge infrastructure to empower Indian academia through centralized digital access, rigorous indexing and global scholarly visibility. The portal integrates robust digital tools with high academic standards to ensure that Indian research receives the recognition, accessibility and preservation it deserves. The initiative is established in association with the *Protection of Child and Human Rights Foundation (PCHR Foundation)*. The PCHR Foundation strengthens DRISTI's commitment to academic justice, equitable access and inclusive participation in the dissemination of scholarly knowledge, especially for underrepresented communities and institutions.

Platform Infrastructure and Technology

DRISTI Portal is powered by the internationally recognised *Open Journal Systems (OJS)*, an open-source journal management and publishing platform developed by the *Public Knowledge Project (PKP)*. With utilising OJS, DRISTI Portal provides journals and editorial boards with an end-to-end system for:

- Manuscript submission, review and editorial workflow management
- Open-access publishing with customisable licensing
- DOI (Digital Object Identifier) integration and CrossRef registration
- Role-based access for authors, reviewers, editors, and readers
- Metadata-rich indexing compatible with global academic databases
- Multilingual interface support and XML/HTML/PDF publication formats

The OJS-based system ensures that DRISTI Portal meets current international publishing standards, facilitates discoverability and enables seamless academic communication between authors, institutions, and global researchers.

Objectives of DRISTI

1. **Digital Hosting of Scholarly Journals:** DRISTI Portal provides a seamless platform for the digital hosting of peer-reviewed academic journals from institutions across India. Each hosted journal is given a unique identity and URL, enabling global accessibility.
2. **Open Access and Inclusivity:** The platform is built on the principle of *knowledge for all*. DRISTI Portal advocates for open access and ensures that high-quality academic content is accessible to students, researchers, and the public at large, regardless of geography or institutional affiliation.
3. **Indexing and Metadata Tagging:** DRISTI Portal includes a structured and advanced indexing framework, categorising journals and articles by discipline, language, region and academic theme. Each publication is tagged with standard academic metadata, enabling accurate discovery and citation.

- A *nationally governed, academically curated* platform to maintain quality and integrity.
- A mechanism for *preservation and intergenerational access* to research in India and abroad.

Moreover, DRISTI Portal provides smaller colleges, state universities and independent research groups the infrastructure they often lack; leveling the playing field in academic publishing and scholarly recognition.

DRISTI Portal is committed to maintaining rigorous academic quality and ensuring all hosted journals and publications meet globally recognised publication norms. The platform incorporates the following standards and protocols:

- **ISSN Registration:** Each journal hosted on DRISTI Portal is assigned or supported in acquiring an *International Standard Serial Number (ISSN)* issued by the *ISSN India, New Delhi* to formalise its global identity.
- **Peer Review Standards:** Journals hosted on DRISTI Portal are required to adopt double-blind or open peer-review systems. Review transparency, ethical guidelines, and editor-author integrity are central to DRISTI's publication model.
- **Indexing Compatibility:** DRISTI Portal is built with full metadata and OAI-PMH compliance for integration with major academic databases, including:
 - a. Google Scholar
 - b. Directory of Open Access Journals (DOAJ)
 - c. Indian Citation Index (ICI)
 - d. J-Gate
 - e. Web of Science and Scopus (where applicable within 2 years)
- **Metadata Structuring and Standard Formats:** All content published on DRISTI Portal includes structured metadata as per Dublin Core, MARC21, and PKP native schemas. Articles include abstracts, author details with affiliations, ORCID linking, keywords, licensing, and citations in standard referencing styles.
- **Archival and Digital Preservation:** The portal supports preservation through LOCKSS and CLOCKSS systems and institutional archiving. All journals benefit from long-term digital sustainability and access resilience.
- **Publishing Ethics and Integrity:** DRISTI Portal upholds ethical standards in line with the *Committee on Publication Ethics (COPE)*, *International Committee of Medical Journal Editors (ICMJE)* and *Open Access Scholarly Publishers Association (OASPA)*. Journals are
